V. Reports

- a. Student Council: Planning to help at the Holiday Craft Party and hold another bake sale. Current topics of discussion include a Valentine's Party and options for community service. High school students were surveyed about the choice of themes for Prom and the winning theme was "Masquerade." Promises Bridal has donated 16 dresses.
- b. Enrollment Report: Enrollment is at 439.
- c. Director of Special Services: Fall 1 SPED reporting is due December 16 Jenifer Doane and Nichole have been working toward clearing up any errors. The number of families who qualify for McKinney Vento has risen this year and CTs are still filling out housing forms for those qualify. There have been PBIS staff trainings on how to implement positive behavioral approaches and strategies to student interactions.
- d. Directors Report: Attended CSDC conference focused on budgets and compliance reporting. Tim also addressed one-time categorical funding of \$303,000 for arts, music and instructional materials. Funding of Learning Recovery Block Grant of \$735,000 is to be spread out and used for tutoring those with academic support plans. There is also an additional one-time grant funding of \$4,000 for Ethnic Studies. Alder Grove will enter into an MOU with NHUHSD for resources regarding the Community Schools Grant. Tim also stated that this will be the last virtual meeting under Brown Act flexibility. Also addressed were the changes to the Dashboard for 21-22, the update of the employee handbook, and Jen Burtram receiving a competitive grant which was only awarded to 17 schools. Tim also called for a Board resolution to address our surplus fund saving for the purchase of a facility in the future.

e. Leadership Team Report: Stefani stated that the Leadership Team had a presentation on the Community Schools Grant provided by Jory McComas. Leadership team also discussed a field day/wellness event to take place on a Thursday afternoon in February, keeping graduation on a Thursday and the development of a parent information brochure/checklist. Ideas for the Prop. 28 Art and Music Block Grant were also addressed. Some ideas were improving our curriculum and book collections and the suggestion of a mural painted on our building.
